Will Call Delivery Browns Fuels shall fill Customer's propane/heating oil tank upon Customer's request, provided that such request is made two (2) working days in advance of the desired delivery date. In the event that Customer requires delivery in less than two (2) working days, or outside of regular working hours, including weekends and statutory holidays or requires less than the specified minimum volume, a delivery charge will be paid by customer. Such delivery charge and minimum volume will be subject to change from time to time without notice. The delivery charge and minimum volume as of the date of this contract are \$150.00 and 200/450 litres for propane and heating oil, respectively. Customer must select one of the above PRIOR to signing this agreement. A mark must be placed in the appropriate box.

CUSTOMER shall pay for each delivery at the Browns Fuels then current posted price in force at the time and place of delivery, which price may be changed without prior notice. CUSTOMER shall give a written notice to Browns Fuels of CUSTOMER'S intent to vacate the premises. Purchases are due and payable on receipt of the delivery invoice. However, a credit cost of.......2% per month (26.8 % per annum) shall apply to any past due balance. Browns Fuels shall endeavor to maintain at all times a sufficient heating oil supply in the CUSTOMER'S tank(s). However, CUSTOMER shall forthwith advise Browns Fuels should fuel level in the tanks) drop below normal, and shall inform Browns Fuels in writing of any modification affecting the storage capacity of the tank's) or CUSTOMER'S heating needs, so that oil deliveries can be planned accordingly. Browns Fuels shall not be responsible for any damage resulting from any inadequate reserve level of fuel if delivery address remains unoccupied by an individual for more than 48 hours, or if for any reason whatsoever oil consumption is unusually high or for any reason beyond Browns Fuels control, Browns Fuels is prevented or delayed in making its propane/heating oil deliveries.
